## **WINTER STORAGE AGREEMENT**

- A. The Owner to each boat must have a valid insurance carrier and policy number.
- B. Winter storage contract in effect from October 1, 2019 through May 1, 2020.
- C. Boats will be launched based on requested date and your boats position in the yard.
- D. There are no guarantees your boat will be launched on exact date requested.
- E. **Owner agrees not to hold JJ Boat Works LLC liable for any loss caused by delay in launching, winter storage, transporting or commissioning caused by weather or any other event beyond the control of JJ Boat Works LLC.**
- F. The integrity of shrink wrap is not guaranteed in winds over 50 mph and is only designed to last one season.
- G. Any boat that shrink wrap is compromised will be removed completely to prevent any damage to surrounding boats and will only be re-wrapped at owner's expense.
- H. Any damage to boats caused by torn or damaged shrink wrap due to excessive winds is not the responsibility of *JJ Boat Works LLC*.
- I. All boats stored on *JJ Boat Works LLC* properties must be power washed at the Owners expense. No exceptions.
- J. All holding tanks must be emptied before bringing boat in for winter storage.
- K. If holding tanks are not emptied, they will be pumped by *JJ Boat Works LLC* at Owners expense.
- L. Winterization of engines and listed equipment is only for protection against freezing. *JJ Boat Works LLC* is not responsible for engine failure, spring starting or spring commissioning.
- M. Only *JJ Boat Works LLC* employees are permitted to apply bottom paint.
- N. *JJ Boat Works LLC* shall have statutory maritime liens (state and federal) upon the boat, motor and attached equipment to secure any and all services and materials supplied to Owner by *JJ Boat Works LLC* during the term of this agreement.
- O. Owner shall not remove their vessel from the rented space until all charges secured by the contract described in section 'N' have been satisfied.
- P. Owner agrees to reimburse *JJ Boat Works LLC* for reasonable attorney fees and cost relating to a suit or other collection efforts by *JJ Boat Works LLC* against Owner to collect any amounts due under this agreement or any amounts due and secured by the contract described in section 'N' of his agreement.
- Q. If Owner fails to remove in a timely manner their boat and/or equipment from the rented space at the termination of this agreement, *JJ Boat Works LLC* shall have the option:
  - Charging Owner daily rent on a pro rated basis for the space occupied
  - Taking possession of the vessel and/or equipment and locking it to the space;
  - Moving the vessel and/or equipment to another location
  - Pursuing any other action available under law.



## **WINTER STORAGE AGREEMENT**

- R. Owner shall not list boat for sale, show, advertise, demonstrate, or transfer ownership of the boat while in storage without prior written consent of *JJ Boat Works LLC*.
- S. Owner agrees to have the watercraft covered by a full marine insurance package (hull coverage as well as indemnity and liability coverage). Owner agrees to release and discharge *JJ Boat Works LLC* from any and all responsibility or liability for injury (including death), loss, and damage to persons or property in conjunction with *JJ Boat Works LLC* facility, marina, or equipment. This release and discharge shall cover without limitation any loss or damage resulting from *JJ Boat Works LLC* employees parking or hauling Owners boat, vandalism, theft, fire, hail, high/low water, wind collision, freezing, ice, rain or any other act of God.
